“CALLS FOR SERVICE”



The first section of this report is the “Call for Service” Report. This is a listing of the calls that were made for police assistance in the City of Spring Grove. In 2012 we had a total of 562 “Calls for Service,” that compares with 737 in 2011. There were an additional 73 calls that the sheriff’s department responded to that are not included in this report. It appears that most of these calls occurred while I was on vacation. The reduction in the “Calls for Service”, I believe is certainly from the reduction in staff and the reduced visibility. The “Calls for Service” that were handled by the sheriff’s department from January to about June are included in this list, but any calls handled by the sheriff’s department for the second half of the year on not included in this total.

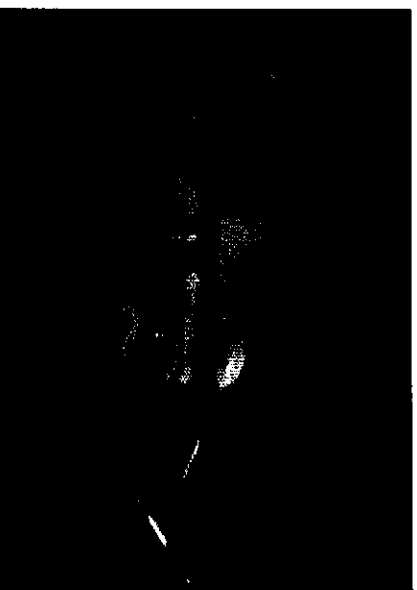

Criminal Cases Investigated



After a "Call for Service" has been received and an officer responds, we have two functions to perform. We take the necessary actions to complete the call. For example, in the case of where we are called to unlock a vehicle, because the owner locked the keys inside, and once the vehicle is unlocked, the call is complete and we have no further action. In the event that we have determined that there has been a crime committed, an investigation is started. The evidence is collected and the victims and/or the witnesses are interviewed. There are also situations where the sheriff's department initially responds to the call, but the case is referred back to the police department for further investigations and follow-up.

In 2012 there were **185 criminal cases** that we conducted further investigation into. Here is the breakdown of the cases that we investigated. You will also find the page entitled "Investigation Clearance." This describes how the cases were brought to a final conclusion. As a note, the totals do not match in sections of this report as there are many cases that have multiple charges that are filed. Last year we spent approximately **247.17 hours** of my time conducting investigations.

The calculation concludes that we had a **CASE CLOSURE RATE OF 87% FOR THE YEAR.**

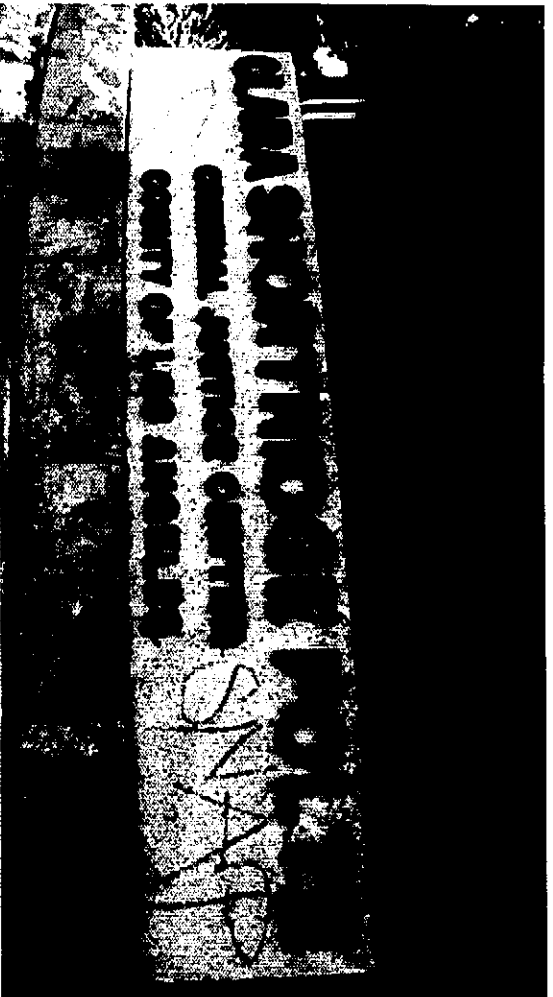

Where did I put my time in?



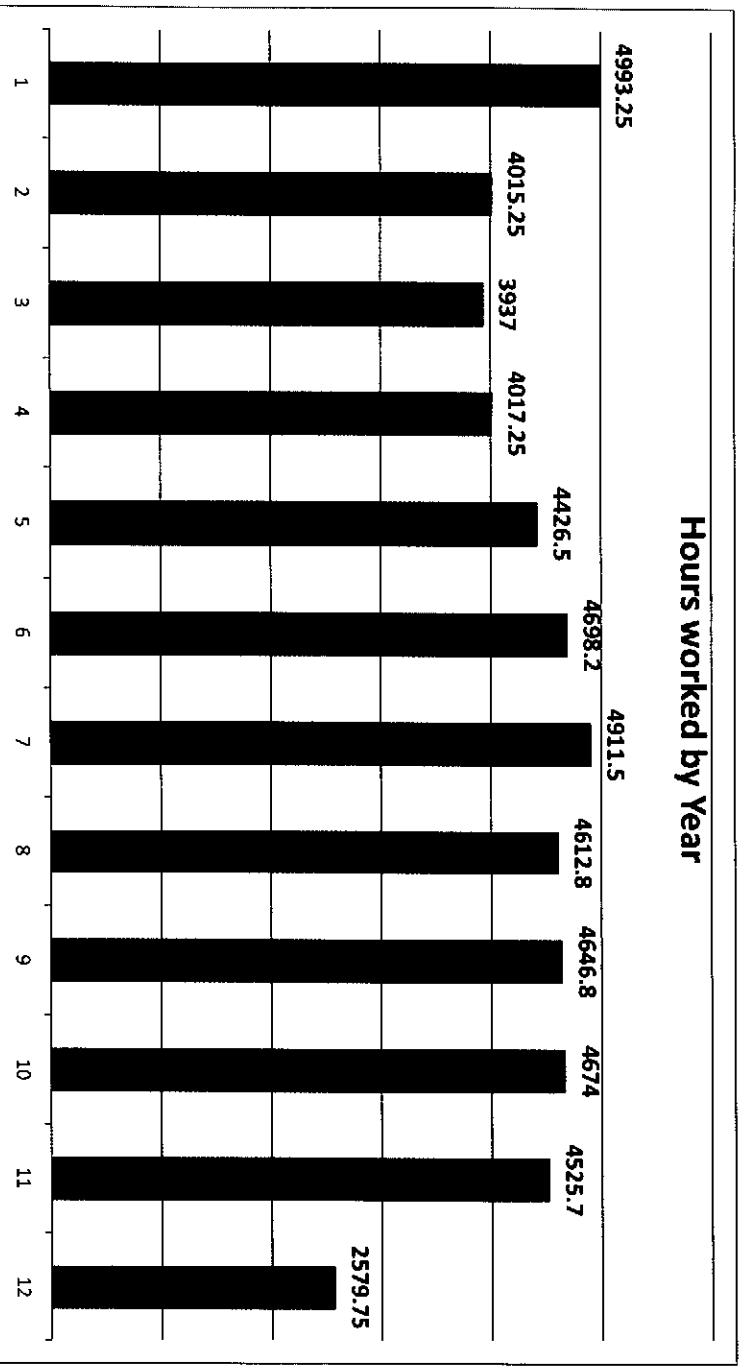

Other Items of Interest

One of the interesting things that the council may not be aware of is the amount of revenue that is generated through the police department. In 2010, it is estimated that the police department generated over \$5,200.00 dollars in revenues. Revenues came from fines that were imposed by the court, NSF check collections fees. Another \$11,500 comes from State reimbursement for training and retirement. *The police department generated a total revenue sum of more than \$20,816.59 for the year.* As a note, the police department also processed and collected for local businesses a total of \$4,197.29 in Dishonored (Bad) Checks in 2012.

The following chart demonstrates the fiscal responsibility of the police department. 2012 was an exceptional year by the fact that we reduced the staff by one full time officer, but consistently we have demonstrated our financial responsibility to the tax payers by trying to save money when we can and spend less.
